Article V UNITS OF EQUITY OWNERSHIP

<u>Section A:</u> <u>Authorized Units of Equity Ownership</u>: The maximum number of units of equity ownership units the Company is authorized to have outstanding is 10,000 units, all of which shall be identical units.

Article VII PURPOSE AND POWER

The Company shall be formed for any lawful purposes and shall have unlimited power to engage in and to do any lawful act concerning and all lawful businesses for which companies may be organized under the Florida Revised Limited Liability Company Act. In connection with the above-mentioned purposes, and without intending to limit the above-mentioned purposes, the Company shall have the power to invest its funds in real property and securities, to acquire, own and dispose of real and personal property, and to do all other acts incidental and necessary to the accomplishment of the foregoing purposes, to the extent permitted under the Florida Limited Liability Company Act.

Article VIII INDEMNIEICATION

The Company shall not indemnify any Member and/or Member-Manager in the event of:

(i) a breach of such Member and/or Member-Manager's duty of loyalty to the Company or its Members,

(if) acts or omissions not in good faith or which involve intentional misconduct or knowing violation of the law,

(iii) a transaction from which such Member and/or Member-Manager derived an improper personal benefit,

(iv) acts or omissions for which indomnification is prohibited under the Florida Limited Liability Company Act, or

(v) judgments, penalties, fines, and settlements arising from any proceeding by or in the right of the Company, or against expenses in any such case where such Momber and/or Member-Manager shall be adjudged liable to the Company.

Any indemnification provided for in this Article (unless ordered by a court) shall be made by the Company only as authorized in the specific case upon a determination that indemnification of the Member and/or Member-Manager is proper in the circumstances because such Member and/or Member-Manager had met the applicable standard of conduct set forth in this Article. Such determination shall be made:
