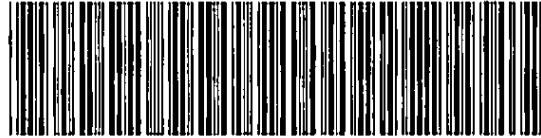

THIRD: The effective date of dissolution of the Company is the date of the filing with and acceptance by the Florida Department of State of these Articles of Dissolution.

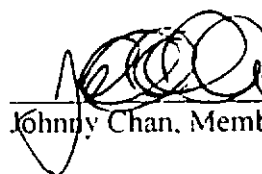
FOURTH: The Company is dissolved by the unanimous consent of its Members pursuant to Section 605.0701(2), Florida Statutes.
