ARTICLES OF ORGANIZATION OF MOUNT VERNON INVESTMENTS, LLC

The undersigned hereby certifies that he is executing these articles for the purpose of forming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
