

ARTICLES OF ORGANIZATION

OF

EZ SIGNATURE LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, heretogeness, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be EZ SIGNATURE LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 866 West Timberland Trail, Altamonte Springs, Florida 32714 and the mailing address shall be the same.

ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE 7 - ADMISSION OF NEW MEMBERS

No additional member(s) shall be admitted to the Company except with the unanimous written consent of all the member(s) of the Company and upon such terms and conditions as shall be determined by all the member(s).
