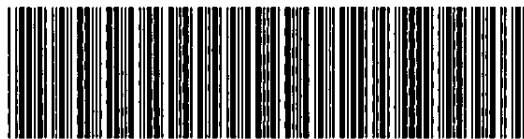

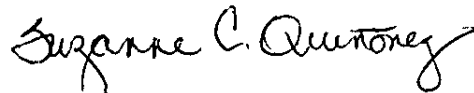

ARTICLE I
Name of Company

Ground Operations Development, LLC

ARTICLE II
Business of Organization

The limited liability company may engage in the business of training for law enforcement officers and civilians, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III
Principal Place of Business

The principal place of business of the limited liability company shall be 3740 Chasing Falls Road, Orange Park, Florida 32065, and the mailing address shall be the same.

ARTICLE IV
Duration

The existence of this limited liability company shall commence upon the filing of these Articles of Organization with the Florida Department of State, and thereafter it shall have perpetual existence.

The members hold their interests individually payable on death to their spouses.

As defined under Section 605.0102 (41) and set out in Section 605.0407, Florida Statutes, the limited liability company will be member-managed. The members with a majority-in-interest as defined in Section 605.0102 (37), Florida Statutes.

The member or members remaining after the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or any other event which terminates the membership of a member, has or have the right to continue the business of this limited liability company subject to approval by the unanimous vote of the remaining member or members; provided that there is at least one remaining member.

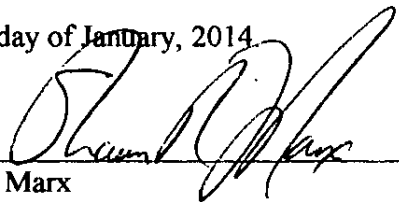

This limited liability company reserves the right to amend, alter, and repeal any provision contained in these Articles of Organization in accordance with the Florida Limited Liability

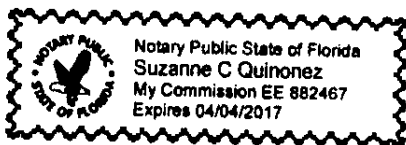
