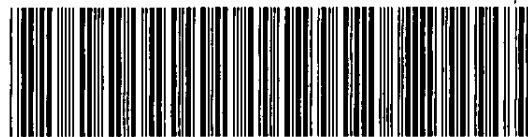

PURPOSE


This Limited Liability Company may engage in any activity or


