ARTICLE I NAME

No Member shall be obligated to make any contribution to the limited liability company except those specifically set forth in the Operating Agreement adopted by the Members of the limited liability company.

ARTICLE VIII DISSOLUTION

This Company shall be dissolved with the written consent of all its Members.

The Company shall file all annual reports required by Florida between January 1 and March 1, beginning the year after the Company's creation, as required by Florida Statutes 608.4511.

The Articles of Organization shall be amended from time to time as required by Section 608.411.

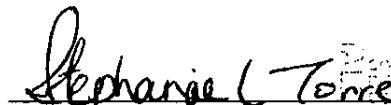
