# ARTICLES OF ORGANIZATION



# 437 OREGON, LLC (A FLORIDA LIMITED LIABILITY COMPANY)



# **ARTICLE 1 - NAME**

The name of the Limited Liability Company is 437 Oregon, LLC (the "Company").

## ARTICLE 2 - PERIOD OF DURATION

Unless earlier terminated under the Florida Revised Limited Liability Company Act ("the Act") or the Operating Agreement, the period of duration of the Company shall be perpetual.

# ARTICLE 3 – PURPOSES, POWERS AND CAPITAL CONTRIBUTIONS

- A. <u>Purposes</u>. The purpose for which this Limited Liability Company is organized is any and all lawful business.
- B. <u>Powers</u>. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 605, <u>Fla. Stat.</u>, as the same may be amended from time to time.
- C. <u>Capital Contributions</u>. The Members shall make contributions from time to time as required by the Operating Agreement adopted by the Company.

## ARTICLE 4 - EFFECTIVE DATE

These articles shall be effective upon filing.

# ARTICLE 5 – ADDRESS OF PLACE OF BUSINESS

The mailing address for the Company is P.O. Box 27684, Panama City, Florida 32411, and the street address of the principal office of the Company is 4620 Bay Point Road, Ste. 1041, Panama City, Florida 32408. These addresses may be changed from time to time as provided in the Operating Agreement.

# ARTICLE 6 - REGISTERED AGENT

The initial registered agent in Florida for the Company is Brandais Management Services, LLC and the initial registered office is located at 4620 Bay Point Road, Ste. 1041, Panama City, Florida 32408.

### **ARTICLE 7 – MEMBERS**

The Company shall have at least two members and may admit additional members on the prior unanimous agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

#### ARTICLE 8 – CONTINUITY OF BUSINESS

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or on the occurrence of any other event that terminates the continued membership of a Member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all remaining Members of the Company.

#### **ARTICLE 9 - MANAGEMENT**

The Limited Liability Company is a manager-managed Limited Liability Company. The Limited Liability Company shall be managed by Brandais Management Services, LLC, 4620 Bay Point Road, Ste. 1041, Panama City, Florida 32408, who is or will be designated, appointed, or elected to act in such capacity in accordance with the Operating Agreement of the Limited Liability Company.

Brandais Management Services, LLC, as manager, shall carry out and further the decisions and actions of the managers or members made under the Operating Agreement and shall be authorized to execute any and all reports, forms, instruments, documents, papers, writings, agreements, and contracts, including but not limited to deeds, bills of sale, assignments, leases, promissory notes, mortgages and security agreements, and any other type or form of document by which property or property rights of the Company are transferred or encumbered, or by which debts and obligations of the Company are created, incurred, or evidenced, which are necessary, appropriate, or beneficial to carry out or further such decisions or actions.

# **ARTICLE 10 – INDEMNIFICATION**

Except as expressly provided in the Operating Agreement, the Company shall indemnify any Member, manager, or former Member or manager to the full extent permitted under Chapter 605, Fla. Stat.

#### ARTICLE 11 – ADOPTION OF OPERATING AGREEMENT

The Company shall adopt an Operating Agreement for the Company, which agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 605, Fla. Stat.
