The name of the Limited Liability Company is CC AVE MARIA MIDDLEBROOKE, LLC.

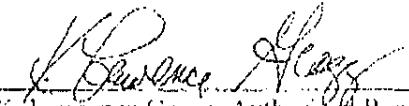
ARTICLE II - ADDRESS

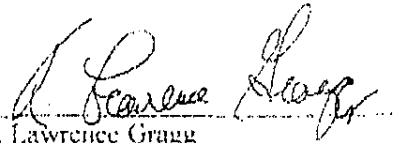
