The mailing address and street address of the principal office of the Limited Liability Company is 825 Coral Ridge Drive, Coral Springs, FL 33071.

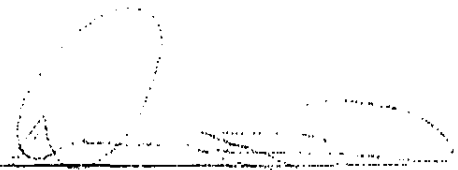
ARTICLE III - INITIAL REGISTERED AGENT
