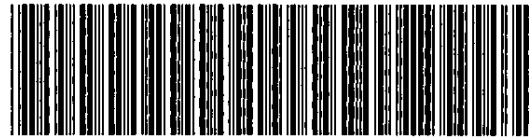

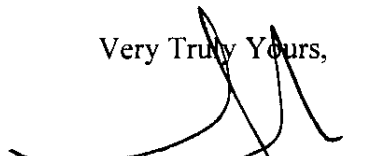

- 5.2 Powers of the Company. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of the laws of the State of Florida.

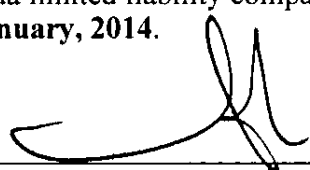
