ARTICLES OF ORGANIZATION
OF
EMERALD COAST PROPERTY LIEN RESEARCH, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is EMERALD COAST PROPERTY LIEN RESEARCH, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 3045 Robertson Road, Pensacola, Florida 32507, and its mailing address is 3045 Robertson Road, Pensacola, Florida 32507, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE III
MANAGEMENT

The business of the Company shall be manager-managed by Managers selected by the Members. The initial Managers shall be WILLIAM FOX, 3045 Robertson Road, Pensacola, Florida 32507, and MICHAEL CAMPBELL, 11436 Aruba Drive, Pensacola, FL 32506, each of whom shall serve as a Manager of the Company until his resignation or death, or as otherwise provide in the Operating Agreement of the Company.

ARTICLE IV
RESTRICTIONS ON MEMBERSHIP

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members and the Managers.

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Chapter 605 of the Florida Statutes, and approved by the Managers of the Company, as shall be prescribed by the Department of State, and shall be signed and sworn to by all members of the Company and the Managers. In the event a new member is added by such amendment, it shall also be signed by the member to be added.

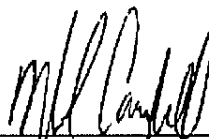
