ARTICLES OF ORGANIZATION OF JJ Sells PowerSports, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be JJ Sells PowerSports, LLC, ("company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 4550 Claire Rose Court, Mount Dora, Florida 32757.
