

The present name of this Florida limited liability company is *Cite Partners, LLC* (the "Company"). The date of filing of the Company's Articles of Organization was February 10, 2014.

ARTICLE I - NAME

This Company shall be a manager-managed limited liability company. The name and address of the Managers of the Company are as follows:






