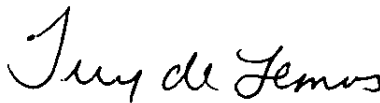

**ARTICLES OF ORGANIZATION
FOR

A FLORIDA LIMITED LIABILITY COMPANY

**ARTICLE I
NAME**

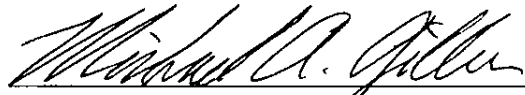
**ARTICLE III

MANAGEMENT**

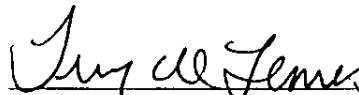
