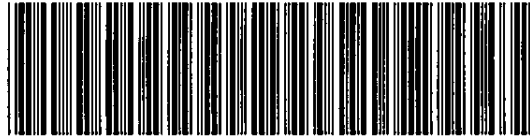

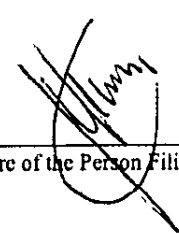

the LLC for over one year. He was involuntarily withdrawn as a Member and Manager.

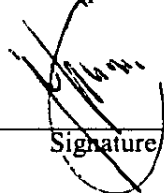
