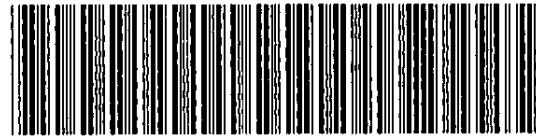

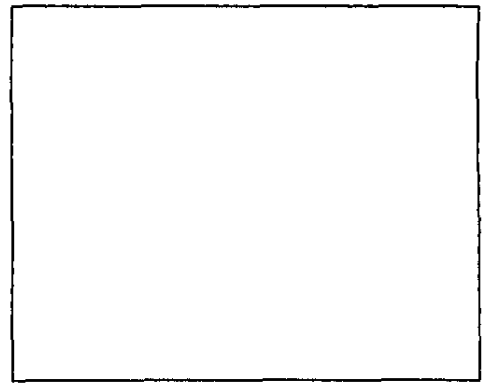

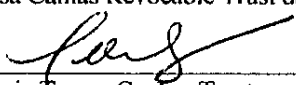
**ARTICLE V
