**ARTICLES OF ORGANIZATION OF
CHARLES E. CHAPLEAU, M.D., NEUROSURGERY, PLLC**

The undersigned, Charles E. Chapleau, M.D., a natural person competent to contract and member of CHARLES E. CHAPLEAU, M.D., NEUROSURGERY, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 605, *Florida Statutes*.

ARTICLE I

The name of the professional limited liability company is:

CHARLES E. CHAPLEAU, M.D., NEUROSURGERY, PLLC

This professional limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing address and street address of the principal office of the Company is 1717 North E Street, Suite 422, Pensacola, Florida 32501.

ARTICLE III - PURPOSES AND POWERS

This Company is organized for the purpose of providing professional medical services and for any other legal and lawful purpose for which a professional limited liability company may be organized and may exercise all powers and rights which a professional limited liability company may exercise under the Professional Service Corporation and Limited Liability Company Act.

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State, and the Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Company is 1717 North E Street, Suite 422, Pensacola, Florida 32501, and the name of the initial registered agent of the Company at that address is Charles E. Chapleau, M.D.

ARTICLE VI - MANAGEMENT

member has complied with the restrictions, including a right of first refusal, contained in the Operating Agreement for the Company.

ARTICLE IX - AMENDMENT

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.
