Pursuant to our earlier conversation, I am requesting reconsideration, on behalf of my client, for the above listed limited liability company application, which is a new business solely owned by James J. Curran.

As you have mentioned and are aware, there is a similarly named company, Bigg Tyme Motor Sports, Inc. (the "corporation"), which is the reason for your initial refusal to allow the new registration. However, this corporation was also owned by James J. Curran with a 50% shareholder interest, along with another shareholder who owned the remaining 50% of the shareholder interest. After less than a year in business, as a result of unforeseen and unresolved differences, the two shareholders have mutually terminated their business relationship. This corporation is not currently operating, there are no assets being held in this corporation, and the corporation will not be renewed or file its annual report.

Additionally, the name Bigg Tyme Motorsports has been used by James J. Curran personally as a trade name for over five (5) years prior to the formation of the corporation, and continues to use the name today.

Based upon the above facts, I request that you reconsider and allow the registration of the newly formed company, Bigg Tyme Motorsports, LLC.
