The name of the limited liability company is 1108 West Kennedy Blvd, LLC.

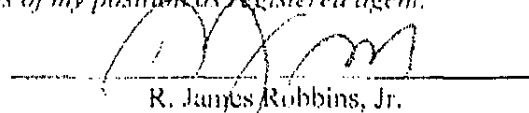
ARTICLE II. ADDRESS
