**ARTICLES OF ORGANIZATION  
OF  
BENIAH, LLC**

The undersigned hereby adopts these Articles of Organization in order to form a limited liability company under Chapters 605, Florida Statutes.

**ARTICLE I  
NAME**

The name of the limited liability company is Beniah, LLC (the "Company").

**ARTICLE II  
EXISTENCE AND DURATION**
