## WRITTEN ACTION OF THE MAJORITY MEMBER OF GROW HEALTHY FARMS FLORIDA, LLC

- 1. The undersigned, GrowHealthy Holdings, LLC, a Delaware limited liability company, is the majority member ("Majority Member") of Grow Healthy Farms Florida, LLC, a Florida limited liability company.
- 2.
