ARTICLES OF ORGANIZATION
OF

The undersigned, acting as an authorized representative of the member of a limited liability company under the Florida Revised Limited Liability Company Act as set forth in Chapter 805 of the Florida Statutes, does hereby adopt the following Articles of Organization for OAKTON CAPITAL LLC (the "Company"):

ARTICLE I

NAME

MANAGEMENT

The Company is to be managed by one or more managers and is, therefore, a manager - managed company.

ARTICLE VI

INDEMNIFICATION

The Company shall reimburse each person for all costs and expenses, including, without limitation, attorneys' fees, reasonably incurred by him/her in connection with any such liability in the manner provided for by law or in accordance with the regulations of the Company. The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein.

The undersigned, being the authorized representative of the member of the Company, hereby certifies that the foregoing constitutes the proposed Articles of Organization of OAKTON CAPITAL LLC.

In accordance with Section 605.0203(1)(b), Florida Statutes, the execution of this document constitutes an affirmation under the penalties of perjury that the facts stated herein are true. The undersigned is aware that any false information submitted in a document to the Department of State constitutes a third degree felony as provided for in Section 817.155, Florida Statutes.


