The undersigned subscriber to these Articles of Organization, being a natural person competent to contract, hereby subscribes to the formation of a professional limited liability company under Chapter 621 of the Florida Statutes.

ARTICLE I - NAME

The name of this professional limited liability company is Carolyn Feltus-Atkinson, M.D., PLLC (the "Company").

ARTICLE II - DURATION

ARTICLE XI - AMENDMENT


The Company shall have the power to amend or supplement these Articles of Organization when approved by unanimous vote of the Members.
