**Purpose and Powers**

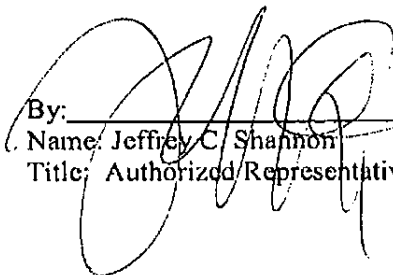
