Except as amended above, said Articles of Organization shall remain in full force and effect in accordance with the terms set forth therein.

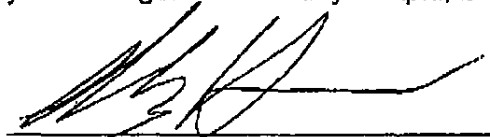
