ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

The name of this professional limited liability company is SRZS Company, PLLC.

This professional limited liability company's principal place of business and mailing address shall be 852 Coldwater Creek Circle, Niceville, Florida 32578.

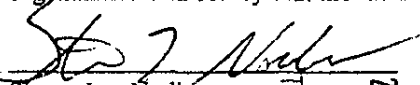
ARTICLE XI - DISSOLUTION

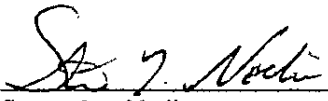
