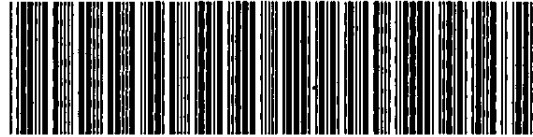

ARTICLES OF ORGANIZATION OF

floridapawnshop.com, LLC

ARTICLE I

Name

The name of the Limited Liability Company is floridapawnshop.com, LLC.

ARTICLE II

Address

The mailing and street address of the Company's principal office is 1499 S. McCall Road, Suite B, Englewood, Florida 34223.

ARTICLE III

Duration

The period of duration of the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV

Registered Agent and Office
