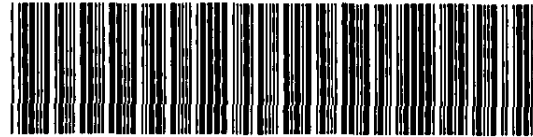

**ARTICLES OF ORGANIZATION
OF
NORTHLAKE ONE, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is NORTHLAKE ONE, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address and street address of the principal office of NORTHLAKE ONE, LLC, is 1405 Shadwell Circle, Heathrow, Florida 32746.

ARTICLE III - DURATION

The period of duration for NORTHLAKE ONE, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE IV - REGISTERED AGENT & OFFICE

ARTICLE V - ADDITIONAL MEMBERS

Additional members to the Company may be admitted, but only in accordance with the provisions contained in the Company's Operating Agreement.

ARTICLE VI - TERMINATION OF MEMBERSHIP

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in NORTHLAKE ONE, LLC, the remaining members may, by unanimous agreement, continue the business of NORTHLAKE ONE, LLC.
