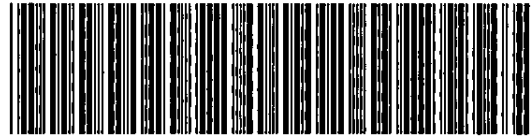



**ARTICLES OF ORGANIZATION
OF
WEKIVA CONDOS, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is WEKIVA CONDOS, LLC.

ARTICLE II - MAILING ADDRESS

ARTICLE III - DURATION


ARTICLE VII - MANAGEMENT


WEKIVA CONDOS, LLC is to be managed by managers and the name and address of the individuals who will serve as the managers are:
