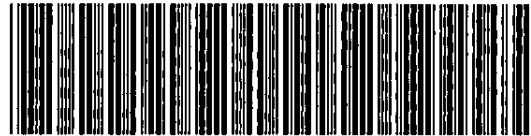



ARTICLES OF ORGANIZATION OF GEORGETOWN ONE, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is GEORGETOWN ONE, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address and street address of the principal office of GEORGETOWN ONE, LLC, is 1405 Shadwell Circle, Heathrow, Florida 32746.

ARTICLE III - DURATION

The period of duration for GEORGETOWN ONE, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE IV - REGISTERED AGENT & OFFICE

ARTICLE V - ADDITIONAL MEMBERS

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in GEORGETOWN ONE, LLC, the remaining members may, by unanimous agreement, continue the business of GEORGETOWN ONE, LLC.

GEORGETOWN ONE, LLC is to be managed by managers and the name and address of the individuals who will serve as the managers are:


