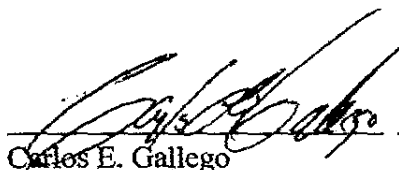
Dear Ms. Lunt,
