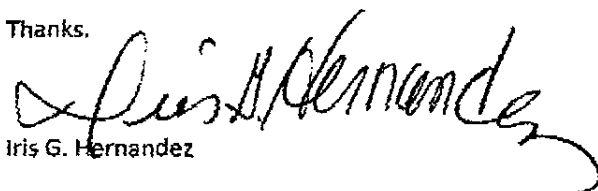
Dear Mr. Shivers,
