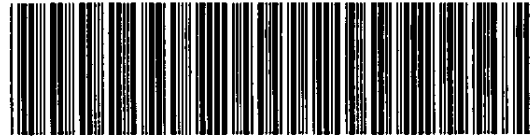

Each member shall make additional capital contributions to the Company only on the consent of the member(s) as set forth in the Operating Agreement.

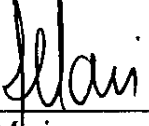
## ARTICLE VIII – ADMISSION OF NEW MEMBERS

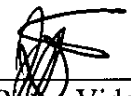
