

**ARTICLES OF ORGANIZATION

The undersigned organizer, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
NAME

The name of the limited liability company is **VarGlobal LLC** (the "Company").

ARTICLE II
ADDRESS

The mailing address and street address of the principal office of the Company is:

ARTICLE III
PURPOSE

The Company is being formed to engage in any and all lawful purpose for which a limited liability company may be organized pursuant to the Act; including but not limited to, any activity or business permitted under the laws of the State of Florida and the United States.

ARTICLE IV

The Company is authorized to issue Ten Thousand (10,000) membership units, par value \$0.01 per unit.


ARTICLE VIII **REGISTERED AGENT AND REGISTERED ADDRESS**
