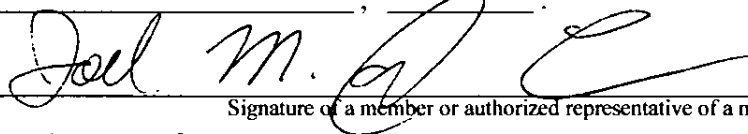
This amendment was to remove Wopaho Holdings, LLC as the Mgr and simply make the organization a member (AMBR) of Virtus Technology Group, LLC.
