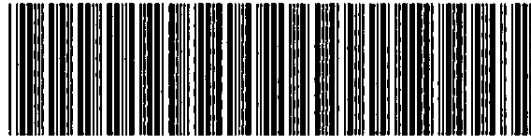

ARTICLE VI – TRANSFER OF INTEREST IN COMPANY

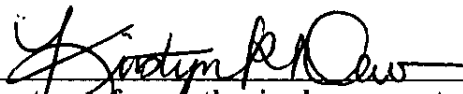

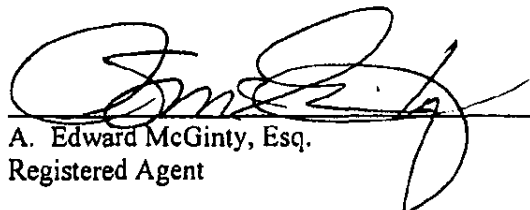
