## AMENDED RESTATED ARTICLES OF ORGANIZATION OF FLORIDA LOYALTY INVESTMENT GROUP, LLC

The undersigned acting authorized representative of all of the members of FLORIDA LOYALTY INVESTMENT GROUP, LLC, adopts and files these Restated Articles of Organization:
