- SECOND:** The Articles of Organization were filed on March 11, 2014 and assigned document number L14000041275.
- THIRD:** The date of the adoption of these Articles of Dissolution is 27 April 2016.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
