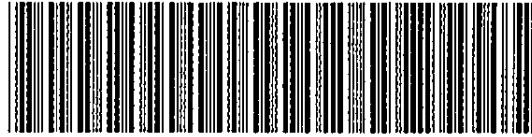

**ARTICLE I.
NAME**

The name of the Limited Liability Company is "Florida Court Appearances, LLC," (the "Company").

**ARTICLE II.
ADDRESS**

**ARTICLE III.

DURATION**
