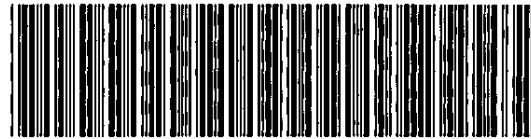

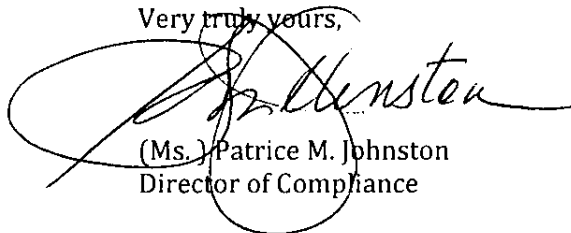

**ARTICLES OF ORGANIZATION  
OF  
BioEkuiliber, LLC**

The undersigned organizer, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The Company is authorized to issue Ten Thousand (10,000) membership units, par value \$.01 per unit.

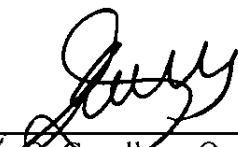
**ARTICLE VIII**
