Operating Agreement

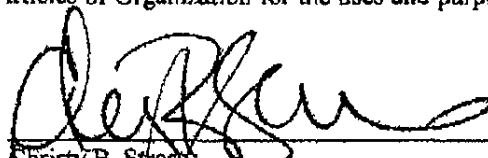
