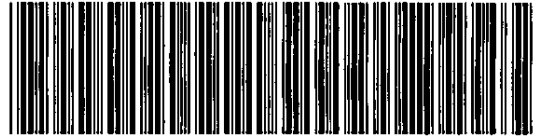



ARTICLE II ADDRESS




