ARTICLES OF ORGANIZATION OF THE IRVINE GROUP, LLC

The undersigned authorized representative of a member of the captioned Limited Libility Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I Name, Mailing Address and Purpose of Organization
