TO
ARTICLES OF ORGANIZATION

The following Articles of Amendment are being submitted in accordance with section 605.0202 of the Florida Statutes.

1. The name of the limited liability company is AXIABIO LIFE SCIENCES INTERNATIONAL, LLC (hereinafter the "Company").
2. The date of filing of the Articles of Organization for the Company was March 13, 2014, and the Company was assigned document number L14000042882.

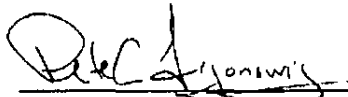
