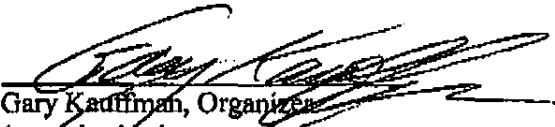
ARTICLE V - MEMBERSHIP RESTRICTIONS
