ARTICLE I

NAME

The name of the limited liability company is **RMMC INVESTMENT, LLC** (the "Company").

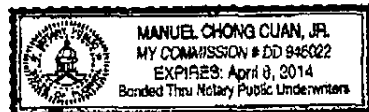
