**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
SOCK LINGO LLC**

Pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, the undersigned, authorized representative of the Members, hereby adopts the following amended and restated articles of organization (the "Amended and Restated Articles of Organization") of SOCK LINGO LLC, a limited liability company duly organized and existing under the laws of the State of Florida, as filed on March 18, 2014 and assigned document number L14000045238, and confirms that these Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

ARTICLE I

NAME

The name of the limited liability company is SOCK LINGO LLC (the "Company").

ARTICLE II

ADDRESS

The principal and mailing address of the Company is 6411 Marlin Drive, Miami, Florida 33158.

ARTICLE III
