TO

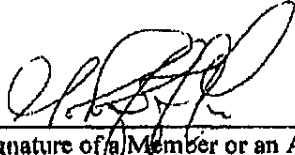
**ARTICLE IV – REGISTERED OFFICE AND AGENT**

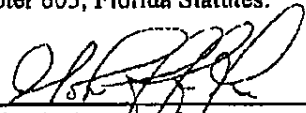
