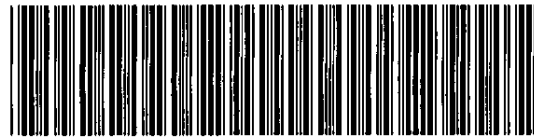

THIRD: The mailing address and street address of the principal office of the Limited Liability Company is 1116 N. State Road 7, Hollywood, FL 33020.


